Available at the discretion of your Provider Lawyer, up to 3 letters on behalf of your home-based business to third parties each month (one letter per subject matter)

#### Business Legal Document Review\*

Up to 3 business contracts/documents reviewed per month, up to 15 pages each

#### Debt Collection Letters

Receive up to three initial debt collection letters per month written on your behalf to a third party.

#### Trial Defense

With your membership you'll receive a 25% discount off your Provider Law Firm's standard hourly rate should your business be charged in a civil action filed in a state or federal district court.

### For your family and your business

#### 25% off additional legal services

You may continue to use your Provider Law Firm for both personal and business legal situations that extend beyond plan coverage. - Garnishment, attachment, other appeals
- Charges of tax fraud or income tax evasions, trust returns, business (including Schedule C) and/or corporate tax returns, payroll and information returns, partnerships, corporation returns or portions thereof that are included in the Member's tax returns, or services rendered by an enrolled agent

#### Will Preparation

- Will with yearly reviews/updates

- Other documents available: Living Will, Healthcare Power of Attorney

#### Motor Vehicle Services\*

- Moving traffic violations
- Accidents: Help with defense for charges of manslaughter, involuntary manslaughter, negligent homicide, or vehicular homicide
- Damage recovery, driver's license issues and personal legal injury assistance (up to 2.5 hours of attorney time, up to \$2,000 per claim)
